## Appendix A Intentional Living Agreement and Rules of Residency

The Wesley Foundation at Stillwater, Inc., is committed to welcoming, valuing and guiding students in a supportive environment. The Wesley residential community is an intentional living community, dedicated to modeling and mentoring young people in a wholesome environment.

**PART I:** As a member of the **Wesley Intentional Living Community**, I commit to abide by the following community rules:

**Tell the truth.** As uncomfortable as it may be, I commit to living with integrity daily with my fellow residents, the Wesley Foundation staff, and myself.

**Take responsibility for myself.** I will clean up my messes, both physical and emotional. I will keep my space clean, and I will own my part when conflict arises.

**Be present and available to the community.** I will participate in weekly community meals. I will be present in periodic "family meetings."

**Participate in making myself better.** I will take my part in making myself the best human being I can possibly be—physically, emotionally, mentally, and spiritually, including asking for help from the community when deemed necessary.

**Participate in making the world a better place.** I will find a place of service within the Stillwater community and commit my gifts and skills to that place.

Be accountable to one another and to the Wesley Foundation staff. Being in community means belonging to one another. Belonging to one another means abiding by rules established by the community and the staff of the Wesley Foundation. I commit to treat the community as I would treat myself.

**Welcome diversity.** Same is boring. We're better together when we're different. I will be open to the new and different ideas from my fellow residents and their guests, even dissenting opinions.

**Respect my fellow residents and their guests.** I commit to treat my neighbors as I would treat myself. I will respect the boundaries of my fellow residents and respect their wishes, especially as it regards media volume and content.

**PART II:** As a member of the **Intentional Living Community**, I accept the following:

**Furnishings**: I will not remove items from the Residence that I do not own or leave any furniture or personal belongings behind upon vacating the residence. I will not use any stickers, nails, or hooks within any part of the Residence, nor apply paint to any surfaces or make any other alterations of any kind or nature to the Unit or Residence without the written approval of the Wesley. I understand that no barbells, firearms, gasoline, or any other hazardous or toxic substance or waste is allowed anywhere inside the Residence or on the Wesley's property. No propane tanks are allowed in the Residence or entry ways.

**Housekeeping**: I agree to keep my unit and suite clean as required by the Wesley and no junk or garbage, or other waste, shall accumulate in the Residence. Trash will be contained in plastic bags and placed in the dumpsters provided.

**Maintenance**: I shall keep the window glass clean and will not cover any window in any manner, which, in the opinion of the Wesley Foundation staff, detracts from the appearance of the Residence. Maintenance needs which are the responsibility of the Wesley shall be promptly reported to the building manager for action. In the interest of my safety and that of my fellow residents I will ensure the unit smoke detector is continually in service and working at all times, including any smoke detectors located in the common areas.

**Tobacco, Alcohol and Illegal drugs**: I understand the Wesley is a tobacco free, alcohol free and drug free facility and reject any smoking, vaping, dipping, or other use of tobacco products or substitutes, or the use alcoholic beverages or illegal drugs on the premises, including parking areas, adjacent sidewalks and patios.

**Visitors, Family Members and Guests**: I understand that I may have guests in my suite or the common areas between the hours of 9 am and 1:00 am. Overnight guests must be registered in advance with the OK State Wesley Campus Minister or appointee, and are limited to 3 nights stay per semester and no more than 2 consecutive nights. My guests and I understand that quiet hours are from 10pm until 7am daily with additional quiet hours to be determined for "Dead Week" and "Finals Week."

**High Speed Internet Access**: I agree that the Wesley reserves the right to determine what uses are and are not permissible and that I will not access the internet service with any personal router or device that further shares the internet service or attempt to access prohibited sites.

**Personal Property Insurance:** I understand that the Wesley Foundation highly recommends that I acquire personal property insurance to cover my personal property housed at the Wesley.
